2. COMPOSITION/INFORMATION ON INGREDIENTS

Active Ingredient: 99.3% Food Grade Garlic Juice. (Garlic Oil)

Solvent: Water.

3. HAZARD IDENTIFICATION

Irritating to eyes. Prolonged skin contact may cause slight irritation.

4. FIRST-AID MEASURES

Eyes: Immediately flush the eyes with copious amounts of water for at least 15 minutes. Call Doctor if irritation persists.

Skin: Remove any contaminated clothing and wash underlying skin with soap and water. Call Doctor if irritation persists.

Ingestion: Wash mouth with water.

5. FIRE FIGHTING MEASURES

Extinguishing media: Keep containers cool by spraying with water. Extinguish source of fire with dry Inert Powder, Foam, Water-spray, or Carbon Dioxide. Do not use Water Jet.

Hazardous combustion products: None. Burning of containers/outers may produce fumes of Chlorine, Carbon Monoxide, Carbon Dioxide and Hydrocarbons.

Protection of fire fighters: Use self-contained breathing apparatus. Wear suitable protective clothing.

6. ACCIDENTAL RELEASE MEASURES

7. HANDLING AND STORAGE
